It is impossible to close the achievement gap without limiting how high the most capable learners can reach. Unfortunately, right now, we are limiting the best and brightest by channeling time and resources into an impossible task.
- 36. When we had local control, we were always at the top of the nation's education!
- 37. The more control we have over this madness the better. We were told yesterday though that the national branch is "dangling" carrots that guide you to choose their choice. Example: Iowa can choose to start taking the SMARTER BALANCE test this year and only need 80% of the students to be proficient, or can choose to wait a year, but then the students would have to be 100% proficient.
- 38. I feel national standards should be used to help guide state programs but national programs should not control what is taught in each state due to different populations and needs of families and students.
- 39. I like a bit of both. I think we should have broader national concept standards, with local autonomy over detailed content standards and benchmarks.
- 40. Education decisions are the state and local governments place. The Federal Government has over stepped its bounds.
- 41. We need to teach to all the students. All learn at different levels and speed.
- 42. And have higher standards the core
- 43. Each state should choose the education standard they follow. I believe it is wrong to have a national standard.
- 44. You can't have the same rules for Iowa as you do for inner cities like Chicago.
- 45. I think lowa has some of its own standards but if our nation is able to adopt the same standards across the board and then get certification to exceed those standards to push students to the next level we should be able to do that. Not that I want our federal government to tell us what is right and wrong about education, but I feel like everyone should be on the same page no matter where they are from. That would unify our education system.
- 46. The idea of a national core makes student transfer from state to state easier, but in general, I don't like the idea of the government dictating what we teach. This should largely be a state decision.
- 47. I believe maintaining freedom for schools, parents, educators, and communities is critical to maintaining limited government our founders set up. Common Core is clearly a federal take-over of education and is being implemented under the cover of darkness from the public.
